The Double Gather trial will be limited to 30 dogs.

Please may I respectfully remind you that all dogs accessing farmland should be wormed every two months.

## **Directions to the Venues**

### **May Trials, Pond Field Copse, Priors Dean**

The trial is situated in the picturesque lanes of Hampshire. You will need to turn left or right off the A32 (depending on the direction you have come from) I believe this is signposted to Petersfield, Froxfield or Steep. Travel up the hill and at the crossroads turn left to Colemore. At the fork keep left, carry on past the tractor dealers on right, turn left and follow road round, the field is on the right.

### **July and August Trials, Manor Farm, Didling**

The trial will be signposted off the A272 between Midhurst and Petersfield.

#### **Rules:**

3. Any dog that injures a sheep shall be disqualified and the owner held liable for damages.
